TERMS AND CONDITIONS

Agreement

All prices quoted are GST inclusive, where GST is applicable.

Confirmation of Booking

A booking will be considered confirmed when the signed Booking Application Form is returned along with deposit payment. Events can be tentatively booked and held for 2 weeks. Management reserves the right to cancel a booking if a deposit for the event has not been paid within 14 days of the reservation.

To confirm your event, a deposit of \$2000 (Including GST) is required. The deposit will be deducted from the total cost of the event.

Final Attendee Numbers

Final numbers must be confirmed no later than seven (7) days prior to the date of the event. At this point an invoice will be generated based on these numbers.

Payments

Guarantee of payment: The contract signatory is personally liable to pay all monies to Eastlake Golf Club pursuant to this agreement. Where the invoice has been requested to be addressed to another person, company or entity, personal liability for full payment remains the responsibility of the contract signatory.

The client must make payment of the total cost by credit card (Master card, Visa or Bank card), cheque or direct debit to Eastlake Golf Club's account no less than five (5) days prior to the commencement of the event. Eastlake Golf Club shall be under no obligation to proceed with the event unless such payment is made.

Food and Beverage

It is necessary to provide your menu selection at least fourteen (14) working days prior to the date of the event. Final numbers for catering purposes (including special dietary requirements) must be received by the club at least seven (7) days prior to the event.

Beverages are charged on a consumption basis. Eastlake Golf Club does not offer beverage packages. Eastlake Golf Club staff are not permitted to serve alcoholic beverages to intoxicated patrons under the Responsible Service of Alcohol Act. It is a policy of the Eastlake Golf Club and the Office of Liquor, Gaming and Racing that individuals or outside organisations are not permitted to provide their own food or beverage for events held at Eastlake Golf Club.

Cancellations

In the event that the client wishes to cancel their event, return of deposit is permitted up until four (4) weeks prior to the scheduled event. Deposits are non-refundable where cancellations are within four (4) weeks of the scheduled event.

Cancellations due to bad weather

Where Eastlake Golf Club closes the golf course and declares the course unfit for play the security deposit will be returned to the client conducting the golf day or an alternative date will be offered. Catering arrangements will be available to proceed subject to discussion and if mutually agreeable, the timing of service may be varied.

Client Instigated Cancellations

In the event that the client wishes to cancel the golf day due to inclement weather, and the course is not closed nor deemed dangerous (lightning) and is available for play, the client will be required to pay 100% of the scheduled booked costs.

Care to the Golf Course

All players are to carry and use a sand bucket to repair all divots on the fairways.

Players are also required to repair pitch marks on greens.

Bunkers must be raked after use.

Electric Golf Carts are to be kept at least 10 metres from greens where paths are not provided and no more than two persons are to travel on the golf cart at any one time. Reckless or careless driving, as determined by Eastlake Golf Club staff, will result in golf cart confiscation

Damages to Carts

In the event where a cart or multiple carts are damaged by attendees to the event, the contract signatory is liable for the cost of the repairs to the carts.

Dress Regulations

Club policy requires all players to be neatly dressed, including:

- Collared shirts and tailored trousers or shorts
- Jeans and cargo shorts / pants are not permitted
- Non-Steel spike golf shoes must be worn
- Running shoes, open toe sandals or thongs are not permitted
